Worldwide cover is not included; Members are advised to obtain appropriate travel cover without a windsurfing exclusion.*

*There is no guarantee that the insurance company will accept a claim as each claim will be evaluated individually. The G.B.S.A shall not be held liable for any misinterpretation or action that may be taken as a result of any submitted claim. A copy of the insurance policy is available upon request.*

### **“Full”**

### **“Family”**

1. Includes Husband, Wife and children aged 16 years or under on the first of January of that membership year living in the same household. All names must be on the membership form.
2. Each named person is covered by the G.B.S.A's Public Liability Insurance policy.
3. Each named person is entitled to enter races held by the G.B.S.A.
4. Receive one copy of regular newsletters.
5. Family members are entitled to vote at the A.G.M.  
They must be aged 17 years or over on the 1st of January of that membership year.

### **“Junior”**

1. Eligible if aged under 17 years on the 1st of January of that membership year.
2. Covered by the G.B.S.A's Public Liability Insurance policy.
3. Entitled to enter races held by the G.B.S.A.
4. Receive regular newsletters.
5. Juniors are not entitled to vote at the A.G.M.

### **“14 Day”**

1. A 14 Day membership for residents and non residents.
2. Covered by the G.B.S.A's Public Liability Insurance policy during the 14 day period.
3. Entitled to enter races held by the G.B.S.A during the 14 day period.
4. Visitors are not entitled to vote at the A.G.M.
